INSTRUCTIONS TO STUDENTS

1. The CSFAA and CSFAR in respect of CSFALs, and the CSLA and CSLRs in respect of CSLs set out the definitive legal rights and obligations of a student. They should be referred to in the case of uncertainty or dispute.
2. This document will not be accepted by the institutions administering your loan after the end of the month shown as confirmed "Period of Studies End Date".
3. All loans negotiated after August 1, 2000 must be administered by the National Student Loans Service Centre. The same lender must hold all loans negotiated prior to August 1, 2000.

If you wish to change lenders, before this document can be accepted by any other lender, the branch of the lender holding your previous full and part-time CSL and CSFAL agreements must, at your request, assign those agreements to a lender of your choice that is willing to accept those agreements.
4. You must provide your previous lender and the NLSLC with a valid **Confirmation of Enrolment** to continue interest-free status on full-time loans or interest-only status on part-time loans, regardless of whether you have applied for a new loan. Failure to do so as required by the CSFAR and CSLR will result in the loss of your interest-free or interest-only status and you may be required to pay interest owing.
5. **If you withdraw** from studies early, your "Period of Studies End Date" shown overleaf will be adjusted to the month of withdrawal and **your interest-free status or interest-only status will end on the last day of the month in which you withdraw.** Contact the lender and the service provider immediately.
